1. This contract is between the Seller, Cheyenne Prow of Selway Australian Cattle Dogs, and the Buyer(s) _____

- All deposits are **non-refundable** unless death or injury of said Puppy/Dog occurs while Puppy/Dog is still in the care of Selway Australian Cattle Dogs.
- All shipping costs are the Buyer's responsibility, if the Buyer does not have a shipper, one will be referred.
- Pick deposits may be transferable if Buyer's state preferences are not fulfilled.
- This contract must be signed at the time the deposit is placed to confirm agreement to all terms. No deposit will be considered final without a signed contract on file.
- Funds accepted at no fee: Cash, Venmo, PayPal, and personal check (deposit only).

3. **2 Year Health Guarantee:** All **PUPPIES** from Selway Australian Cattle Dogs come with a 2-year Health Guarantee against congenital or hereditary defect that are considered life-altering – meaning they significantly reduce the Dog's quality of life, cause chronic pain, or limit normal daily function, as confirmed by a licensed veterinarian.
- Puppy can carry 1 copy of a hereditary disease, which does not mean they have a hereditary disease.
 - Puppy is guaranteed free of Parvo, Distemper, Adenovirus, Parainfluenza, and Rabies 48 hours after transfer. All puppies are in sound condition upon leaving Seller's facility.
 - Buyer must take the Puppy to a licensed veterinarian within 72 hours of receiving him/her. Failure to do so will make the Health Guarantee null and void.
 - This Health Guarantee applies only to defects that are both **CONGENITAL** or hereditary and meet the definition of life-altering as outlined above. Minor or non-impactful conditions are not covered.
 - This guarantee does **NOT** cover illness or disease acquired after transfer. This includes, but is not limited to, Parvo, Leptospirosis, Distemper, kennel cough, respiratory infections, or parasites such as giardia, coccidia, hookworms, or roundworms. These conditions are considered environmental and can be contracted through contact with soil, water, or other animals.

- f. If a licensed vet diagnoses a qualifying congenital or hereditary defect, the Buyer must submit written proof within 24 hours of the exam.
- g. If a congenital or hereditary defect is diagnosed within the Health Guarantee period, the Seller will offer a replacement Puppy of equal value. The Seller may, at their sole discretion, require the original Puppy to be returned or may allow the Buyer to retain the Puppy and still receive a replacement. Return must occur within 30 days of diagnosis to qualify for a replacement.
- h. Replacement puppies must be of equal value, or Buyer will be required to pay the difference. If no Puppy is available, Buyer will be placed on priority waiting list.
- i. Seller is not responsible for any veterinary costs, diagnostics, or medications REGARDLESS of the outcome.
- j. Any transport (either to bring the Puppy back or obtain a new Puppy) is the responsibility of the Buyer.
- k. Puppies are vaccinated with DHPP appropriate to age. Buyer acknowledges that Puppy is not fully vaccinated and must avoid high-risk environments (dog parks, rest areas, etc.) until the vaccine series is completed.
- l. Buyer is responsible to have a licensed veterinarian administer the rest of the vaccine series/regimen following the vaccines given by the breeder. The first DHPP (5-way) vaccine is given at 6 weeks, the second at 8 weeks. A 9-way vaccine should be administered at 12-13 weeks, followed by a second 9-way vaccine 16-17 weeks.

To maintain this Health Guarantee:

- m. Buyer agrees to delay spay/neuter until at least 18 months of age for males, or after one full heat cycle and no earlier than 18 months of age for females, unless spay or neuter is deemed medically necessary by a licensed veterinarian with written vet documentation. **Early spay or neuter will void the 2-year Health Guarantee in its entirety.**
- n. Buyer agrees to feed WSAVA guided food (4 health, Taste of the Wild, Purina, Royal Canin, etc.) no grain free, to avoid DCM/heart conditions. If your Puppy is found to have a heart condition, proof of feeding compliance (e.g., receipts) is required for replacement consideration.
- o. These are not conditions of sale, but they are required for the Health Guarantee to remain valid.

4. PET OWNER RESPONSIBILITY: Upon transfer of possession of the Puppy/Dog (pickup or delivery), Buyer assumes full legal ownership and responsibility including all veterinary care and associated costs. Buyer further agrees to provide Puppy with a proper diet, complete the recommended vaccination series, and seek veterinary care as needed to ensure the Puppy/Dogs ongoing health. Buyer also agrees to keep Dog on a monthly parasite deworm regimen for the first 6 months, followed by deworming at least every 6 months thereafter. Buyer agrees the Puppy will never be improperly housed, kept on a chain or tie out, or left unattended to run at large. Puppy will be treated as a loved and valued member of the family. Proper socialization and training are the Buyers responsibility. Seller is not responsible for temperament or behavioral issues that develop after transfer.

5. FULL RIGHTS purchase: Breeding Rights of said Puppy have been purchased.

Buyer acknowledges that this agreement conveys breeding rights subject to the terms and restrictions set forth below.

- a. Ownership transfer may be permitted for legitimate reasons, but only with Seller's approval.
- b. Buyer must notify Seller if they intend to rehome the Dog. Seller retains first right of refusal and must be notified. If Seller repurchases the Dog, they'll pay no more than the original price. All return transport costs are the Buyer's responsibility. If Seller declines to repurchase the Dog, Buyer may proceed with rehoming, subject to Seller's written approval.

- c. Dog may not be bred until a championship title is completed with AKC in either conformation, obedience, rally, and/or agility.
- d. Buyer shall not breed the Dog until OFA's for hips, elbows, breed-appropriate genetic testing, and BAER hearing testing have been completed; the Dog may only be bred to a AKC registered Dog meeting the same testing requirements.
- e. All breeding under this agreement must adhere to the recognized breed standard and ethical breeding practices for the breed.
- f. Buyer agrees not to breed the Dog before 1.5 years of age, or before the second heat cycle, whichever comes later.
- g. No crossbreeding is permitted. Breeding to any other breed constitutes a breach of this agreement and will result in either a \$2,500 non-compliance fee or mandatory return of the Dog to Seller, at Seller's discretion.

6. Full Rights Guarantee:

- a. Buyer will receive a breeding/show quality Dog, free of genetic defects and/or conditions that disqualify the Dog from being bred. If said Dog is found to have a defect or condition that disqualifies the Dog from breeding, a replacement Dog of equal or greater value will be issued.
- b. Buyer must provide written documentation from a licensed veterinarian stating why the Dog is not breeding sound. The Dog must be spayed or neutered before replacement, and proof of spay/neuter must be provided. All spay/neuter and shipping costs of replacement Dog/Puppy are the Buyers responsibility.
- c. If a hereditary or congenital defect is diagnosed, the Dog must not be bred. Breeding a Dog with a known or suspected genetic condition is a breach of contract and voids any Health Guarantee or eligibility for replacement.
- d. Examples of defects covered under the 2-year Health Guarantee include heart defects, cryptorchidism, dysplastic hips or elbows, Dudley nose, and eye defects.
- e. Faulty bite is not covered for replacement, as bite issues can develop unpredictably and may be influenced by, but not limited to, factors such as nutrition, including imbalances of calcium, phosphorus, and vitamin D during development.
- f. Cosmetic traits or conditions that do not affect the Dog's health or breeding soundness are not covered under this guarantee.
- g. This guarantee applies only to the original Buyer and is non-transferable.

7. Registration:

- a. Our Dogs are registered with AKC or American Stock Dog Registry (ASDR).
- b. The Seller will register all Dogs/Puppies.
- c. Buyer must decide on a registration name within 2 weeks after Puppy is transferred to the new owner. If registration name has not been selected within that time, Seller will choose a suitable name.
- d. It is required that "SW Selway" be included in said Puppy's AKC registered name; "Selways" shall be used for ASDR registration.
- e. Seller shall remain listed on AKC registrations; ASDR registrations will be issued in Buyer's name.

8. Contract Jurisdiction:

- a. This contract is governed by the laws of the State of Idaho and falls under jurisdiction in Idaho County.
- b. The legal venue for any disputes shall be Grangeville, Idaho.
- c. All attorney fees and court costs incurred will be the responsibility of the Buyer.

This agreement exists to protect the health, future, and integrity of our dogs, our program, and the families we serve.

9. Acceptance of Contract

I, the undersigned Buyer, have read, understand, and agree with all the terms and conditions set forth in the purchase contract. I understand this agreement goes into effect upon signing and remains binding once I take possession of the Puppy/Dog.
